TERMS & CONDITIONS OF PURCHASE - GOVERNMENT SUPPLEMENT (TCP-GS)

If this Order shows on its face that it is placed in support of a U.S. Government (USG) funded prime contract or subcontract, or if the Buyer otherwise notifies the Seller that this Order is placed under a USG prime contract or subcontract, the following clauses of the Code of Federal Regulations (CFR), the Federal Acquisition Regulations (FAR) and the Department of Defense Federal Acquisition Regulation Supplement (DFARS) apply and are incorporated herein in addition to Axillon Aerospace Corporation Terms and Conditions of Purchase - Commercial (Form TCP) by reference with the same force and effect as if set forth below in full text. These clauses apply to all Firm-Fixed Price (FFP), Cost Reimbursable (CR), and Time & Material/Labor Hour (TM/LH) purchase orders, as appropriate.

Seller further agrees that all notifications and other communications required by these clauses shall be made through the Buyer's Supply Chain/Purchasing Representative unless this Order specifically provides otherwise. During the performance of this Order, Buyer shall reserve the right at any time to change/amend/update any clause in this document.

CFR Clause
